

Historic Legislative Achievement Secured: Passage of the Inflation Reduction Act (IRA)

In September, President Joseph Biden signed into law the largest investment in American clean power in U.S. history – the IRA. The bill includes:

- ✓ The most stable federal tax structure the industry has ever had – over a decade of full value Production Tax Credit and Investment Tax Credit extensions.
- ✓ A suite of new incentives for standalone energy storage and green hydrogen.
- ✓ Advanced manufacturing incentives to spur domestic production across solar, storage, and onshore and offshore wind.
- ✓ New incentives for procuring domestic content and for siting projects in energy communities.

The IRA's policies will deliver an estimated 525 to 550 gigawatts of new, utility-scale clean power from 2022–2030. This will drive an estimated 40% reduction in emissions, create 550,000 new clean energy jobs, and support a direct workforce of nearly one million Americans by 2030.



Founded in 2021, ACP has already delivered major victories for the industry.

And we're just getting started.

IRS Guidance:

Secured favorable guidance from Treasury/IRS in 2021 providing additional time for COVID impacted projects to finish without putting tax credits at risk.

CBP Solar Import Headwinds:

Drove the creation of a new set of guidance meant to create a more implementable framework for solar product imports under the Withhold Release Order (WRO).

Section 201 Tariffs:

Coordinated industry efforts to push back against renewal of existing tariffs on solar products and secured an exemption for bifacial modules and a larger tariff rate quota (TRQ).

Commerce Anti-Circumvention:

Coordinated industry efforts to secure a 24-month waiver of tariffs on imported solar products which could otherwise be assessed due to a pending Commerce Department administrative proceeding.

Gold Eagle Protection Act:

Developed a general permit program with three environmental groups to help the wind industry deal with liability under the Bald and Golden Eagle Protection Act.

IIJA Transmission Provisions:

Secured several key provisions including federal siting for interstate transmission, a transmission facilitation program, funding for programs to enhance grid flexibility and resiliency, and borrowing authority for Power Marketing Administration including transmission.

Offshore Wind:

Rallied bipartisan opposition to legislative supply chain mandates that would impede offshore wind development, advocated for more predictable federal permitting process, coordinated with multiple federal agencies to maximize acreage in forthcoming lease sales, removed the offshore wind moratorium in the South Atlantic, developed concept and advanced policy discussion on regional fisheries compensation fund.

Regulatory Reforms:

Ensured regulatory agencies undertook numerous sweeping reforms, consistent with ACP recommendations, that will help drive the deployment of clean energy, such as Federal Energy Regulatory Commission (FERC) proposing broad transmission reforms, Bureau of Ocean Energy Management (BOEM) increasing leasing and permitting for offshore wind, and Bureau of Land Management (BLM) revisiting its regulations to better incent renewables on public lands.

State Affairs:

From accelerating transmission build in California to beating back onerous permitting and siting restrictions in Virginia, ACP's State Affairs Directors and partner networks are on the ground representing the clean energy industry's interests in state capitals and local jurisdictions across the country.

An Ambitious Policy Agenda to Drive the Industry Forward

ACP works with its members to define an ambitious policy and advocacy agenda at the federal, state, and local level. This agenda is designed to clear the barriers to deployment, create market stability, and protect the long-term interests of the industry.

ACP members have the ability to shape the association's priorities, specific policy stances, tactical decisions, and the market research we conduct on your behalf.

- **Secure favorable Treasury guidance and agency rulemaking** for the implementation of clean energy tax provisions in the Inflation Reduction Act
- **Enable stable and responsible supply chains**
- **Pursue workable siting and permitting rules** at the federal, state, and local level
- **Facilitate transmission build out and market rules** needed to underpin the build out of clean energy resources
- **Address state-level policies** that could either enable or harm clean energy growth
- **Build political strength** with both sides of the aisle
- **Shape the narrative** about the industry during a period of rapid scaling post IRA







Wind and solar leveled cost of energy




4-Hour Energy Storage and Solar + Storage Levelized Cost


