For requests received before 5:00 pm EST, June 1, 2021, all sums paid by the EXHIBITOR, less a service charge of 50% of the EXHIBITOR FEES, will be refunded. EXHIBITOR shall pay the remaining 50% EXHIBITOR FEES, to the extent not already paid, within three calendar days following its delivery of the CANCELLATION REQUEST. If a CANCELLATION REQUEST is received after 5 p.m. EST on June 1, 2021, EXHIBITOR shall not be entitled to any refund of EXHIBITOR FEES and shall be responsible to pay 100% of the EXHIBITOR FEES, to the extent not already paid. EXHIBITOR shall pay such amounts within three calendar days following its delivery of the Cancellation Request.
