 - Jan 7, transfer of ANSI accreditation from AWEA to ACP with the updated scope. New SDP. Received approval of application on Feb 16 from ANSI, March 5 ANSI published new scope to SA w/ 30-day public comment period.
 - Special audit still needed. We have a few standards that are ready for the audit phase. These documents are ready for the BSR9. We have three documents ready for the BSR9 form. Once ready, we will notify ANSI.

 - ii. Michele Mihelic, ACP, noted that the non-ACP standards Offshore Safety Subcommittee has four documents they are working on: electrical, transfers, lifting, and LOTO. This is being led by Geoff Neild.

 - i. Jon and Luke provided the following update: Endorsement of A17.8 The group has created a scope document for the WEHSSC to review. Document will be added to the Drafts tab of SpecBuilder for the group to review. 30-day comment period. The group is looking for thorough comments.

- a. Discussion: Broaden committee scope
- b. Gemma Smith, National Grid Renewables, noted that right now the group focuses on wind. With the broadened ACP scope, does it make sense for this group to broaden its scope.
 - i. Chris Daniels, Mortenson, noted that the committee scope should mirror the scope submitted to ANSI.
 - ii. Michele Mihelic, ACP, noted that regardless the scope needs to be updated to switch AWEA to ACP.
 - iii. Chris Daniels, Mortenson, asked if it's ok to stay wind.
 - iv. Michele Mihelic, ACP, noted the group can.
 - v. Karl Delooff, Acciona, noted he's a fan of keeping it as one family with subcommittees/task forces with subject matter experts looking at the different technologies. There are a lot of overlap and synergies that can happen, but there are a few areas that are unique that may need to be broken out like tower rescue for wind, fire fighting for batter storage, etc. There are a lot of commonalities to be used.
 - vi. Chris Daniels, Mortenson, noted that there may be a concern with meeting quorum.
 - vii. Michele Mihelic, ACP, noted probably not, we will expand membership, I don't think it will be an issue.
 - viii. Chris Daniels, Mortenson, noted if there isn't a concern, then he don't have any issue.
 - ix. Link Diwan, HSB Hartford Steam Boiler, asked about other standards committees. Something we should do across the board? Or each making own decision?
 - x. Michele Mihelic, ACP, noted that each committee making a decision. Looks like WTSC will stay wind. WWSC is up in the air, they are still trying to digest.
 - xi. Cynthia Cuenin, Tempest Group, noted so much on that plate on wind industry community, if we broaden to solar, etc. it may be harder to get this accomplished with other areas of interest.
 - xii. Link Diwan, HSB Hartford Steam Boiler, noted from insurance side, it would be nice to have less groups developing safety standards.
 - xiii. Michele Mihelic, ACP, noted as far as I know we are the only ones focusing on EHS.
 - xiv. Link Diwan, HSB Hartford Steam Boiler, noted from an overall standards and insurance side, it would be best for WEHSSC group to drop the wind and be the EHSSC. There's a lot of integration on the ground and one set of standards would be beneficial. Subcommittees can be created as needed, if we don't have the volunteers then that standard doesn't get developed.



- xv. Gemma Smith, National Grid Renewables, asked the group, are we ready to vote on this or do we need more time to discuss.
- xvi. Chris Daniels, Mortenson, noted we should make a decision after the group has time for discussion.
- xvii. Karl Delooff, Acciona, made a motion to expand the scope of the committee to match the new scope of ACP standards. Recommend use the term clean power. Chris Daniels, Mortenson, 2nd.
- xviii. Karl Delooff, Acciona, made a motion for a vote, Chris Daniels, Mortenson, 2nd. 20, approved. 3 opposed. Motion approved.
