# ACP Board Governance

ACP members have a number of forums to engage and lead the industry's efforts. One of those is the Board of Directors, a diverse and committed group of leaders selected each year.

All ACP members are eligible to submit a request for nomination to serve on the Board and have two pathways to be nominated for a Director position:

## 1) Elected Directors:

All members are eligible to submit a request for nomination to be elected to the Board. Further details on the process, criteria, and timing for elected positions can be found [here](#). **The deadline to submit a request for nomination is October 22, 2021.**

## 2) Appointed Directors:

Any member company that contributes a total of:

- \$730,000 or more is eligible to automatically appoint a Director to ACP's Board.
- \$1M or more is also eligible to automatically have a role on the Executive Committee.
