ACP membership is designed to ensure equitable access for all clean power companies. Each member receives the same baseline benefits, regardless of their dues. The dues contribution for each member is right sized to account for your overall size and interest in clean power, which is defined as:

- **Three Year Revenue Average:** A three-year trailing average of revenue (2021, 2022, and 2023)
 - when in doubt, please estimate to the best of your ability
- **ACP Covered Technologies Only:** This only applies to revenue generated from ACP-covered activities of solar, storage, onshore wind, offshore wind, transmission, and green hydrogen
- **U.S. Only:** This only applies to revenue attributable to the U.S. market
